The Fair Education Act SB 48

The California Education Code has been updated over time to ensure that the contributions of members of underrepresented racial, ethnic and cultural groups to the economic, political, and social development of California and the United States are included in history and social studies lessons. To this end, California Education Code's Social Content statute requires that instructional materials:

Portray accurately and equitably the cultural and racial diversity of American society;

Demonstrate the contribution of minority groups and males and females to the development of California and the United States;

Emphasize people in varied, positive, and contributing roles in order to influence students' school experiences constructively; and

Not contain inappropriate references to commercial brand names, products, and corporate or company logos.

The FAIR Education Act, SB 48 (Leno), was signed into law on July 14, 2011, and went into effect on January 1, 2012. It amends California Education Code to include the Fair, Accurate, Inclusive and Respectful reference to contributions by people with disabilities and members of the LGBT community in history and social studies curriculum.

CTA Elects Toby Boyd as President, David Goldberg as Vice President andLeslie Littman as Secretary-Treasurer

LOS ANGELES –Toby Boyd, a member of the 24-leader Board of Directors, was elected to a two-year term as president of the 325,000-member California Teachers Association during the quarterly meeting of the State Council of Education in Los Angeles. CTA Secretary-Treasurer David Goldberg was elected Vice President. Leslie Littman, also a member of the CTA Board of Directors, was elected Secretary-Treasurer. Their terms begin at the end of June.

"We congratulate Toby, David and Leslie for their victories today," Heins said. "Their combined passion, commitment and knowledge of the association and teaching profession makes them a well-equipped team to lead the board of directors and the association through the next two years. With the Red for Ed movement growing across California and across this country, we need a unified leadership team ready to speak out for our students and ensure that our schools, colleges and communities have the support and resources needed to help all students succeed. I know this team will continue to engage all educators in the work of our union and will stand up to the corporate special interests and anti-public education forces that are actively trying to privatize our schools."

Boyd, 60, of Elk Grove in Sacramento County, draws on 23 years in public education as a teacher, MESA (Mathematic, Engineering, Science Achievement) advisor and elementary coordinator for Elk Grove Unified School District, and also served as the liaison between the school district and the universities involved with the program.

Goldberg, 47, is currently serving his second term as Secretary-Treasurer. He has been an educator for more than 20 years spending most of his career as a bilingual teacher at Murchison Elementary in the Los Angeles Unified School District (LAUSD).

Littman, 50, of Santa Clarita in Los Angeles County, has taught AP US History, Economics and Government at Hart High School in the William S. Hart Union High School District for 23 years.

The State Council of Education is comprised of 800 democratically-elected educators from across the state and is the union's top governing body.


